On February 6, 2002 a personal interview of (b)(2)high was conducted at The Office of the Resident Agent in Charge, Hartsfield International Airport, Atlanta, Georgia. As a result of investigation conducted thus far, several businesses and individuals have been identified as associated with CIRCLE. In the previous telephonic interview conducted with (b)(2)high detailed the relationship between CIRCLE associates Gerard MARCHELLETTA, Jr. (MARCHELLETTA), (b)(6)(b)(7)(C).
